F. Discussion of open policy proposals (1)

- 2015-04
 - “RIPE Resource Transfer Policies”
 - at the end of (second) review phase
 - * *no* consensus
 - * main opposing argument: change of structure of policy documents, from “resource oriented” to “process oriented” has sustained opposition
 - short presentation by Erik Bais
 - then Q&A, and feedback from the room

F. Discussion of open policy proposals (2)

- 2015-05
 - “Revision of Last /8 Allocation Criteria”
 - v2 in discussion phase
 - fairly heated discussion on list
 - * two camps: “must preserve addresses for future participants” vs. “give (me) more space”
 - * unclear whether consensus can be reached
 - short presentation by Radu-Adrian Feurdean
 - then short Q&A, discussion later

F. Discussion of open policy proposals (3)

- 2016-03
 - “Locking Down the Final /8 Policy”
 - new proposal
 - quite a bit of discussion
 - * fairly complex restrictions, goals not clear
 - * unclear whether consensus can be reached
 - short presentation by Remco van Mook
 - then Q&A, and feedback from the room

F. Discussion of open policy proposals (4)

- Last /8 - General Direction?
- two competing proposals on the table
 - 2016-03 making policy more restrictive
 - 2015-04 loosening up policy (somewhat)
- both are unlikely to reach consensus
- which direction do we want to go?
 - *restrict* IPv4 policy (2016-03-ish)
 - keep things as they are
 - *loosen up* IPv4 policy (2015-04-ish)

F. Discussion of open policy proposals (5)

- ideas floating around...
- want to encourage / incentivize IPv6 adoption
 - how can our policy reach LIRs that have enough IPv4?
- restrict last-/8 /22s to *new* entrants?
- try to reclaim IPv4 space from “big fat old LIRs”?
 - would be truly retroactively changing rules(!!)
